Other Deadlines :

Corporation Tax

The timelines for Corporation Tax and the submission of limited company accounts are contingent on your company's accounting period, typically spanning 12 months but potentially extending to 18 months when initiating trading.

The Corporation Tax return covers a 12-month period, and the associated deadlines are as follows:

- Submit your company accounts to Companies House within 9 months following the conclusion of your accounting year.
- Ensure the payment of Corporation Tax is made no later than 9 months and one day after the conclusion of your accounting period.
- File your Corporation Tax return within 12 months after the conclusion of your company's chargeable accounting period.

During your initial year of trading, the deadlines differ, and you will receive notifications from both Companies House and HMRC regarding them.
